Friends of LETS FEED THE KIDS BACKPACK PROGRAM are pleased to announce the date for our first annual golf tournament and silent auction to benefit our LFTK backpack program. On June 28, 2014 we will be holding our annual event at the Beaver Valley Golf Club in Patterson Heights, Beaver Falls, Pa.

LFTK is a non-profit organization, whose mission is to stop hunger in Aliquippa Elementary school. We supply kid on the school free lunch program with non perishable nutritious food to take home with them over the weekend. This program runs for 36 weeks from Sept -May. This school is at 83% on the free and reduced lunch program. This year we were able to feed 40 students for the entire school year. The cost of each backpack is \$5.00 a week per child or \$180 a year per child.

The elementary school has about 500 students on the free and reduced lunch program. Can you imagine this many kids in our back yard not getting enough to eat .This will affect there grades, their health and their lives. We need to stop it before it get out of control will you help me stop it. My goal for this year is to feed 80 kids in the 2014-2015 upcoming school years.

Making this golf tournament successful for these kids can only be accomplished with the generosity of you and your corporation/company.
